WORKSAFELY Kicks off Winter Roads Safety

Isolated communities in Manitoba rely heavily on the construction of Winter Roads each year. Once the roads are constructed transport companies can haul essential goods such as food, building materials, equipment and other important commodities across the winter roads. MIT (Manitoba Infrastructure and Transportation) is responsible to oversee the construction of the winter road system and contracts the services of construction companies from the northern communities. MIT requires the contractors to be safety trained and COR™ certified.

Winter road construction is dangerous work and workers are continually exposed to severe hazards such as hypothermia and break through ice hazards. Medical help and facilities are not readily available and therefore workers require on-going safety training to ensure their safety.

MIT contracts the services of WORKSAFELY to train and COR[™] certify contractors and their employees who build the winter roads. COR[™]/ SECOR Winter Roads Safety training will be held in



Safe Work Practices for the Heavy Construction Industry ...a Supervisor's Tool

CELL PHONES ON CONSTRUCTION PROJECTS

The use of cell phones has spread across the globe and is now integral in most aspects of personal and professional life. But certain places—for instance construction sites--should remain cell phone free because of the inherent risks brought on by multitasking in zones generally filled with dangerous, life-threatening situations.

Talking on a cell phone at a construction site can be dangerous in many ways. If you are involved in crane lifts, concrete pours, excavation work, confined space work, road work, traffic control, working at heights or any other dangerous labor and you are not devoting full attention to the task because you're on the phone or texting, structural integrity may be compromised and costly damage (in money and lives) may occur.

Most people have emergencies and important events that they need to learn about as soon as possible, but this doesn't justify using a personal cell phone at work, especially when one is involved in a construction related task or activity that is extremely dangerous to a single employee's health and welfare or that of the entire crew.

Rules for Cell Phone Use on Construction Sites

To safe guard all employees on the construction site against injury, the following rules apply to cell-phone use on construction sites

- Cell phone use or texting on construction sites is strictly prohibited unless authorized by the construction supervisor. (see below)
- Cell phone use or texting while operating any mobile equipment on the construction site is strictly prohibited. Cell phone use or texting is strictly prohibited while attending safety meetings or tool box talks.
- Employees may use their cell phone for personal calls during lunch or rest breaks, but only in designated areas
- Cell phone use for supervisors will be limited to the construction trailer, site office or designated safe area away from general work activities.
- Supervisors are prohibited from taking calls or making calls while directing activities on the work site.

Where urgent family matters requires cell phone contact with family members, employees are required to bring these concerns to the supervisors attention, so the supervisor may ensure all work activities are carried out

Non-conformance to the above cell phone rules can lead to immediate termination or suspension of employ-

CSO Designation: The Right Choice for the Construction Industry

Construction Safety Officer (CSO) is an ideal training application for today's construction supervisors or foremen. CSO certification provides a valuable resource to management in the administration and implementation of a company's safety and health program, construction project planning, and implementation.

CSO certification is recommended to those responsible for assisting management (and other company personnel) in the administration, implementation, and maintenance of a safety and health management system or program. They will identify and review various safety and health concerns specific to the worksite and communicate effectively with government, management, and workers regarding safety and health at the worksite and within the company. Individuals applying for CSO certification must demonstrate:

- A minimum of three (3) years of practical safety/construction related experience (or equivalent) in the heavy construction industry
- Practical knowledge in health and safety skills combined with field experience as it pertains to the work in heavy construction.

The CSO applicant must complete the following prior to certification:

Obtain certificates for all mandatory courses

- Obtain a minimum of two certificates from a list of elective courses
- Conduct and submit three toolbox talks and three current site inspections
- Conduct and submit an audit on the National Standard audit document
- Complete the final written exam and attain a minimum of 80%

WORKSAFELY understands the importance this CSO designation provides to a company and offers the CSO examination and certification program in Manitoba for Heavy Construction Industry.

COR™ CERTIFICATION - New Government Wide Tendering Policy

The recent announcement in June 2011 by Manitoba Infrastructure and Transportation regarding the new Province Wide Tendering Policy expands contacting opportunities for contractors, both large and small. Beginning January 2014, regardless of the project value, all bidders and subcontractors (subcontractors with employees working on the project) will be required to have a valid and current COR™ or SECOR certificate or evidence of equivalency.

The new tendering policies further expand the "condition of contract" obligations for contractors and sub-contractors specific to $COR^{\mathbb{M}}$.

The Bidder's Certification Form is a key requirement of the Tendering policy and sets out the minimum Workplace Health and Safety policy requirements for Manitoba Infrastructure and Transportation capital projects. These requirements are stated as:

Where the contract award value for the project is \$100,000 or greater:

 Bidders with employees working on a project must have a valid and current COR™ or SECOR certificate, or evidence of equivalency issued in accordance with the Canadian Federation of Construction Safety Association's COR™ program and verified by either the Manitoba Heavy Construction Association WORKSAFELY Program or by the Construction Safety Association of Manitoba.

 Subcontractors are not required to declare status in a safety program, until January 1, 2012.

Beginning January 1, 2012, subcontractors with employees working on a project must show safety program registration or evidence of equivalency verified by either the Manitoba Heavy Construction Association **WORKSAFELY** Program or by the Construction Safety Association of Manitoba. Beginning January 1, 2014, and regardless of project value, all Bidders and Subcontractors (with employees working on the Project) must have a valid and current COR™ or SECOR™ certificate, or evidence of equivalency issued in accordance with the Canadian Federation of Construction Safety Associations COR™ program and verified by WORKSAFELY.

The Contractor shall ensure that its subcontractors provide a signed Bidder's Certification Form to the Engineer before the subcontractor begins work on the Project. It is not necessary for subcontractors to submit a Bidder's Certification Form at the time of tendering.

Importantly, for the purposes of executing the Bidder's Certification Form, "Subcontractors" excludes:

- Suppliers that are delivering products and are not directly participating in construction activities on the project site (i.e. supply only).
- Service providers that are not directly participating in construction activities on the project site.
- Subcontractors without employees (i.e. single owner-operators).
