LTIP roundtable meetings are underway

The federal government's consultations on the Long Term Infrastructure Program (LTIP) are now officially underway. Led by Denis Lebel, Minister of Transport, Infrastructure and Communities and Winnipeg MP Steven Fletcher, who is also Minister of State (Transport) kicked off today the first in a series of roundtables last week on the East Coast.

The goal of the LTIP is to establish a new long-term infrastructure plan that will sustain and improve Canada's infrastructure network, while keeping costs down and ensuring value for Canadians. The LTIP aims to ensure lasting benefits for communities — from large urban centres to rural townships — while contributing to long-term economic growth and job creation across Canada.

Both Ministers Lebel and Fletcher will be meeting with representatives from the provinces and territories, municipalities through municipal associations and the Federation of Canadian Municipalities, as well as other key stakeholder groups. These discussions will focus on broad directions and principles for a new long-term infrastructure plan for Canada that will extend beyond 2014. No date(s) has yet been officially set for Manitoba.

The Government of Canada says its developing a new plan that will continue to deliver results for Canadians through long-term investment programs. This includes exploring opportunities that encourage greater private-sector involvement and public-private partnerships to generate better value for taxpayers, and ensure affordability and sustainability over the long term.

Cities need stable cash

In all the years that I have been commenting upon or writing stories about civic affairs, the word most likely to flow through my fingertips is "infrastructure."

Civic leaders have been complaining for decades about deteriorating old infrastructure, overcrowded new infrastructure, and the need for more infrastructure. Among the first acts of various federal governments has been to commit to provide funds for infrastructure.

This commitment is easy to make. The need is great (at its recent meeting in Saskatoon, the Federation of Canadian Municipalities tabled a document identifying a \$123-billion infrastructure deficit), addressing that need carries the promise of creating jobs and economic efficiencies, and the definition of infrastructure is ambiguous enough to allow politicians to stand before almost any project with an oversized cheque and take credit.

After a freshly elected Liberal government in 1993 kicked off an infrastructure program promised in its Red Book, Quebec City got a convention centre, Calgary added box seats to the Saddledome, and Saskatoon twinned Circle Drive south of College.

In spite of these relentless ad hoc programs, cities continue to complain about the infrastructure deficit. Although the FCM is hopeful that it's on the cusp of an agreement with the federal government for a longer-lasting program, I wouldn't lay bets that two decades from now we aren't hearing the same complaints.

While the lack of adequate infrastructure clearly is a challenge, I would suggest it isn't THE problem for municipal governments. What they lack is an adequate and long-term source of unconditional operating funds that doesn't strangle economic growth, unlike the property tax. This money would allow cities to plan projects, establish reserves beforehand to reduce the size of needed debentures, pay off those debts and provide operating funds – all from the same annual allocation.

Whether it's adding environmental programs, improving police services, addressing homelessness and poverty, or establishing better transportation or housing, municipal governments around the world have proven to be the most innovative. That's because they are closer to the people who otherwise must live with the problems and thus able to tap them for ideas.

I would suggest the best funding source would be to have the federal government collect it through its GST/HST program, with half the money coming from each of the senior levels of government. For provinces with an HST that would mean turning over two percentage points of the tax, and for provinces such as Saskatchewan without an HST, it means either matching the GST amount with an equal grant, or by raising and bolstering the PST. Two GST points would equal about as much money as the Action Canada program that created 100,000 short-term jobs.

Saskatchewan already turns over to municipalities the equivalent of one percentage point of its five per cent sales tax. It could, for example, negotiate a more permanent capital grant and move that to the federal program or simply top it up. It's worth noting this wouldn't alleviate the need for ad hoc capital programs. The Conservative government and municipalities proved the worth of programs in the wake of the global economic crisis, when Ottawa quickly and efficiently pumped \$10 billion into the economy to create more than 100,000 jobs and help stave off a recession. In the process, municipal governments demonstrated how important they are to Canada's economy.

Ad hoc programs also have the advantage of providing a political boost to the politicians with the biggest cheques. Although we all grimace at the gripandgrin photos and the cash wasted on the endless Action Canada signs, these serve the purpose of providing incentive to the governments and accountability to taxpayers.

But ad hoc programs have their shortcomings, not the least of which is that everyone is required to spend a set amount of money in a short period of time on basically the same sort of materials and work. This creates bottlenecks and inflates costs unnecessarily.

If the cities are to succeed in getting better funding program in place, they need to start with the Council of the Federation. Provincial and territorial governments must be the first to demonstrate to Ottawa that they are willing to agree on a mechanism to turn over these tax points to municipalities, on condition that the federal government matches them.

Once the program is established, its adequacy can be measured and local councils held to account for its efficiency. And FCM will know it has been successful if, when the group gathers for its 100th meeting in 25 years, "infrastructure" only appears in the preamble to the president's report.

Summer Conversation Points

Canada Day has ushered in the northern summer, and with it the vacation season that will bring us together with friends and family. Getting to this point in the year has been turbulent, and there is no lack of conversation material. Here's a hit list of economic issues that are likely to make the rounds this summer, and a quick perspective on the key discussion points.

Is Europe going South? Many wonder aloud about the Union surviving the summer. There's a lot to lose if it doesn't, and that's what is keeping leaders at the table. Notice the pattern? Repeated crisis points have led to a sequence of ever-more-creative solutions. Expect this pattern to continue.

Is the US on the mend, or not? Despite fiscal concerns, key data continue to impress. Housing, auto sales, US consumers and factories are all on the rise. Just wait until all this activity unleashes the \$2.3 trillion in cash – about 15% of GDP – that US non-financial corporations are sitting on.

Why are there so few US jobs? Patience. Just like its reticence to part with its money, corporate America is in no rush to hire. Employment is always a lagging economic indicator. But as soon as the business machine believes that the recovery is real – and that's anytime now – watch out.

Why can't I find workers? Unlike the US, Canada is already facing labour constraints, and well ahead of global recovery. Get used to it. Our resource sector is at the near end of an investment boom, and our work force is ageing. Best to develop a strategy that goes beyond mere pay increases.

Most exciting new acronym: TPP You'll be hearing a lot more about this one. The Trans-Pacific Partnership is a new

approach to free trade agreements, and at the recent G-20 meeting in Los Cabos, Mexico, Canada was invited to join the negotiations. Membership will likely require significant changes to Canada's current industrial policy, so at present, it still looks a long way off.

BRIC slowdown: should I worry? The feted emerging market heavyweights are all slowing. It isn't trivial – collectively, they account for 30% of world GDP. Public stimulus has been a big part of their success through the recession-rebound period, and current troubles are a matter of getting the stimulus-mix right. Also, rising US momentum should help them revive again by the end of the year.

Cheaper oil: here to stay? Lower oil prices will help the world economy over the summer months. \$80 per barrel oil isn't likely to persist, but on the higher side, triple-digit crude is too high given world fundamentals. Expect something in between – and hope that pump prices finally follow suit.

There's a lot more to discuss, from Japan's debt bomb (public debt-to-GDP is 205%, vs 170% in Greece), to Mexico's election (will peace and safety follow?), to a rumoured federal cabinet shuffle and then, among many other subjects, there is the London Olympics.

The bottom line? As we mull over these issues over the summer, keep in mind that, barring any major missteps, the world economy should be well on its way to recovery by the autumn. If that good news sinks in, it may begin to lift the debilitating cloud of global pessimism. Have a happy summer!
