## ATTN: ALL PERMIT HOLDERS INCLUDING LONG COMBINATION VEHICLES

RE: Dugald Rd Construction Project and Temporary Detour for LCV'S

This letter is to advise that the City of Winnipeg will be reconstructing eastbound Dugald Road from Ravenhurst Street to the Perimeter Highway beginning September 9, 2024. During construction the eastbound lanes of Dugald Rd. will be closed.

The duration of the project is approximately five (5) weeks, depending on the weather. As a result of this construction project, long combinations vehicles (LCVs) will be temporarily detoured on the outbound and inbound routes below.

<b>Pandora Ave E, 766</b> From city limit at PTH 101 on Dugald Rd, west on Dugald Rd to Ravenhurst St, north on Ravenhurst St to Pandora Ave, west on Pandora Ave to the approach serving 766 Pandora Ave E.	Inbound route OK via westbound Dugald Rd. Outbound route via the approach serving 766 Pandora Ave E, west on Pandora Ave to Day St, north on Day St to Gunn Rd, east on Gunn Rd to the city limit at PTH 101.
<b>Pandora Ave W, 500</b> From the east city limit on Dugald Rd, west on Dugald Rd to Ravenhurst St, north on Ravenhurst St to Pandora Ave, west on Pandora to the approach serving 500 Pandora Ave W.	Inbound route OK via westbound Dugald Rd. Outbound route via the approach serving 500 Pandora Ave W, east on Pandora Ave to Day St, north on Day St to Gunn Rd, east on Gunn Rd to the city limit at PTH 101.
Black Diamond, 500 (provisional approval) Outbound: 500 Black Diamond > Black Diamond eastbound > Mazenod northbound > Dugald westbound > Lagimodiere northbound > City Limit at PTH 59 Inbound: City Limit at PTH 101 (SB lane/ right hand turn only) > Dugald westbound > Mazenod southbound > Black Diamond westbound > 500 Black Diamond.	Inbound route OK via westbound Dugald Rd. Outbound route is not affected.
